**600.9(c)(1)(i) & 600.9(c)(1)(ii)**

Jersey College is a member of NC-SARA. By virtue of signing an enrollment agreement, students acknowledge, understand and agree that (a) the College is approved through participation in SARA (State Authorization Reciprocity Agreement) to offer coursework and programs interstate through Distance Learning, (b) Distance Learning requires compliance with state authorization requirements based on, among other things, Student's state of residency; (c) his/her admission into and continuing enrollment in the Program is based on the state that Student provided as his/her physical presence in the Enrollment Agreement; and (d) if he/she has moved or moves to a different state, continuation of his/her enrollment will depend on the availability of the Program within the new state where he/she is or will be physically present. Student also acknowledges, understands and agrees to that it is his/her responsibility to review the regulations regarding authorization before moving to another state, and that if the College is unable to offer the Program within the other state that he/she will be administratively withdrawn from the Program of study and the College will not be liable for any claims, damages, losses and/or expenses (including reasonable attorney's fees, court costs and disbursements) arising out of or relating to such administrative withdrawal.

Jersey College has made a determination<sup>1</sup> its Practical Nursing program curriculum meets the State educational requirements for practical nursing licensure in the following states:

- by virtue of maintaining a licensed program: (i) Florida, (ii) New Jersey and (iii) Pennsylvania.
- by virtue of graduates becoming licensed within the last five (5) years: (i) Colorado, (ii) Delaware, (iii) Georgia, (iv) Maryland, (v) Michigan, (vi) New York, (vii) North Carolina, (viii) Rhode Island, (ix) Texas, and (x) Washington.

Jersey College has made a determination<sup>1</sup> its Professional Nursing program curriculum meets the State educational requirements for registered nursing licensure in the following states:

<sup>1</sup> The date of determination is January 12, 2026. Jersey College utilizes commercially reasonable efforts to maintain and update the determination of licensure eligibility, including, but not limited to, (i) reviewing on an annual basis the states in which graduates have become licensed within the past five years and analyzing state law, and (ii) updating the disclosure when the College becomes aware of a change in eligibility. Nonetheless, state law and other factors can change from time to time without notice and applicants to the college are notified to contact their Board of Nursing. Individual licensing decisions are at the sole discretion of the Board of Nursing to which the individual applies for licensure.

- by virtue of maintaining a licensed program: (i) Alabama, (ii) Arizona, (iii) Florida, (iv) Indiana, (v) New Jersey, (vi) Pennsylvania, and (vii) Tennessee.
- by virtue of graduates becoming licensed within the last five (5) years: (i) Alaska, (ii) Connecticut, (iii) Delaware, (iv) Georgia, (v) Hawaii, (vi) Maryland, (vii) Massachusetts, (viii) New York, (ix) North Carolina, (x) Ohio, (xi) South Carolina, (xii) Vermont, (xiii) Washington, and (xiv) West Virginia.
- by virtue of an assessment of state law: (i) Kentucky.

Students who seek licensure in a state other than those listed above are not eligible to receive Title IV federal financial aid.

Jersey College has not made a determination whether or not its programs meet requirements in other states.<sup>1</sup>
